Candidates are required to complete 13 weeks of student teaching. These experiences allow the candidates to demonstrate their pedagogical content knowledge. The candidates are visited weekly and evaluated by Full-time faculty supervisors along with the student's cooperating teachers (PreK-12 staff). The lab program takes place with upper-level EDU courses after the students admission to the program, which allows the student to be in the classroom for a longer period of time 4 hours, per class, per week. This gives them a more accurate idea and prepares them for student teaching in their last semester as a senior.

In addition to integrating technology assessments into all of our pedagogy courses, we have a course (EDU 255) that meets the Georgia Technology standards. All of our students are required to take educational technology as a foundation course. We use Google Drive and Sites data tracking, and have implemented an e-portfolio submission site system through Weebly.com for our student evidence and data tracking. These tools provide evidence of program improvement and streamline our records. Our program has recently integrated STEM content into three of our content area courses: EDU 255 (Integrating Technology), EDU 308 (Teaching Mathematics) and EDU 380 (Teaching Science). Our Methodology courses require students to utilize technology and appropriate software to analyze student performance data.

EDU 290: Teaching Exceptional Children is a course required early in the program. This course introduces candidates to the special education referral process, the RTI process, writing and implementing IEPs and allows them to observe and assist in both inclusion and pull out special ed classrooms that address needs that range from visual and hearing impairments to medically fragile, behavior disorders, and a variety of autistic spectrums. All 300 lab courses require candidates to breakdown the special education needs specific to the content they are teaching and address differentiation and accommodations needed accordingly. Candidates in full time student teaching are required to participate alongside host teachers in all training, assessments, and goal setting meetings to address the unique needs in each situation accordingly.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

There is one initial certification Early Childhood Education (ECE) program in the Teacher Education Undergraduate Unit. The ECE program includes the undergraduate and post-baccalaureate levels. All students who graduate receive a minor in reading. We now have a lab program that helps our students carve out longer times frames to be in the field each semester. It is improving their capability to get more out of their experience in the field and gives their cooperating teacher a set schedule for when to expect them. There is one graduate-level program: Master of Education (M.Ed) in early childhood, a non-initial certification program. We also offer an Educational Studies Minor which allows students to take foundational education courses, while majoring in a different subject field. This minor is a non-certification track. The program submitted all required documentation to the institution to transition to Elementary Education beginning Fall 2020.
